2. Recent PMUNY Activities

A. ADVENT Message of Hope 2022 project was very well received by Prison Chaplains and incarcerated individuals. One chaplain reported it was "Very meaningful and powerful, especially the graphic. So much so that many incarcerated individuals hung them on the walls of their cells. They were motivated and deeply comforted by the hand written messages."

Feedback received from one EMP Director and another local church included..."Advent is always a busy time of year. We need more lead time in the future". "We would like to receive PMUNY Advent MOH cards in September in order to properly prepare and implement a well coordinated Advent MOH project with our congregation". PMUNY plans to comply with this very reasonable request.

One church community (St. Louis Pittsford) asked PMUNY to consider a Lenten Message of Hope Project.
